The Burnaby Board of Education operates University Highlands Elementary School on property leased from Simon Fraser University pursuant to the terms of a ground lease. The City of Burnaby has requested that the Board and SFU grant a stormwater management covenant in favour of the City pursuant to Section 219 of the *Land Title Act* for the purpose of ensuring the provision, utilization, maintenance and three-year monitoring of the Storm and Ground Water Management System. The covenant includes a consent and priority agreement by which the Board consents to the granting of the covenant and the registration of the covenant in priority to the lease.
