

The Burnaby B oard of Education (Board) is required to submit to the Ministry of Education and Child Care an Annual 5 - Year Capital Plan that is supported by a Board Long - Range Facility Plan. Major, Building Envelope, and Minor projects require a resolution from the Board authorizing the submission. The development and implementation of the Annual Facility Grant (AFG) Expenditure P lan does not require a Board motion.

The AFG is provided to districts annually from the Ministry for the purpose of:

- x upgrading or replacing existing facility components throughout the expected economic life of an existing capital asset;

AFG funding provided to school districts by the Ministry increased by 22% compared to last year. Burnaby's share of this increase was \$1,053,934.
